Enclosed please find a copy of a new electric tariff for Danvers Electric, as issued by the Town of Danvers (under its Town Manager, Municipal Light Board, and the Electric Utility Director) on July 1, 2019.

DESCRIPTION

NEW RATE

Electric Vehicle Charging Station Charging Rate (EV-1) M.D.P.U. 143

The Electric Vehicle Charging Station Charging Rate (EV-1) has been created to correspond with Danvers Electric’s policy to reflect the costs associated with equipment and energy supplied for the public to charge electric vehicles at these Level 2 charging stations. The newly created billing policy is described in detail in the corresponding DPU filing document.

ELECTRIC VEHICLE CHARGING STATION CHARGING RATE (EV-1)

TOWN OF DANVERS ELECTRIC DIVISION

M.D.P.U. 143

AVAILABILITY

Service is available under this rate to any operator of a vehicle that has Level 2 electric vehicle charging capabilities utilizing the Town owned Level 2 electric vehicle charging stations.

HOURLY RATE

Customers parked and plugged-in to the designated electric vehicle charging stations and utilizing the Town-owned electric vehicle charging stations will be charged a rate of \$1.25 per hour.

CONDITIONS OF SERVICE

The Level 2 charging stations installed by the Town of Danvers will be open for public use. The hourly rate will be charged and collected through the Level 2 charging station equipment and passed through to Danvers Electric. Customers will park their vehicles in the designated electric vehicle parking spots, validate their payment method, which will unlock the station so the user can plug the station into their vehicle. Electric Vehicle charging parking spots are for vehicles equipped with Level 2 charging capabilities only. Appropriate signage and pavement markings will be provided by the Town of Danvers for compliance.
